Strengths of the school's SMSC development:

Through your self-evaluation and our discussions it is evident that there are numerous SMSC related strengths at Bower Grove. The following are a few key examples:

- **The world beliefs** curriculum and the way it is delivered provides students with relevant and engaging knowledge that prepares them for living in a diverse world and enhances their experience of inclusion.
- The *Theme of the Fortnight* (TOTF) and *Golden Duck* rewards system provide opportunities for developing and embedding positive values and attitudes and an appreciation of individual achievements and respectful behaviours.
- The drive to provide extra-curricular opportunities enriches the students lived experience, provides *awe and wonder* and enables them to develop a sense of achievement and self-worth.
- The robust development plan and curriculum planning provides a clear framework that is planned, assessed, and reviewed and supports the individualised pathway for each student to develop a strong sense of belonging and community.

Areas for development:

- Consider becoming a beacon/ champion school for SMSC provision to share good practice with other neighbouring schools and enrich opportunities for students to share their own achievements and development.
- Revisit extra-curricular provision in light of lost opportunities due to the pandemic.
- Explore Post Covid provision for mental health and wellbeing of staff and pupils.
